Entries must be received by closing date at 5:00 p.m. Phone, email and late entries may be refused. A late fee of \$20 will be charged at the discretion of the show management. If cancellations are necessary, a full refund will be made if the show manager is notified before the closing date. All fees must be paid by the closing date unless prior arrangement is made with the show manager. In such case all fees will be due before entering the arena. After closing date, refunds will be made only with a doctor or veterinarian certificate, less \$10.00 office fee. All no-show entries will be billed to the rider.
